12/29/16 through 01/06/17

29-Dec-16 Deputies received a report of a traffic accident at the intersection of Main Ave and 3rd St. the vehicle driven by Jamie Stafford was traveling south bound on Main and the vehicle driven by Frederick Thornton was traveling west bound on 3rd St. Stafford's vehicle was half way thru the intersection when it was struck on the driver's side. Thornton was cited for failing to stop at stop sign and no proof of insurance.

31-Dec-16 Between 12/30/16 and 12/131/16, unknown suspect(s) towed a "go-kart" 4 wheel ATV from a residential property in the Lone Star area. The suspect(s) proceeded east until they rolled the kart on its side and abandoned it in a gully. Case is under investigation.

01-Jan-17 Deputies received a report of a criminal mischief case in Otis. The resident found tires on multiple vehicles had been slashed. Case is under investigation.

02-Jan-17 Deputies responded to a cold burglary in the Lindon Area. Upon arrival it was determined that multiple items were missing from the residence as well as an outside shop. Case is under investigation.

04-Jan-17 Deputies received a report of a possible hit and run. After investigating the incident, it was discover that a family member had driven a vehicle into a family owned building. Case is closed.
